**UPON** application by the Respondent dated 19 October 2021 to set aside the Order of 15 October 2021 and

**FURTHER** to the Order dated 3 December 2020 of the Divisional Court and the judgment of the Divisional Court in proceedings brought by the Attorney General under section 42 of the Senior Courts Act 1981 *HM Attorney- General v G [REDACTED] s [2020] EWHC 3811 (QB)* whereby the Respondent was declared to be a vexatious litigant pursuant to section 42 of the Senior Courts Act 1981 ("the Vexatious Litigant Order") and

**UPON** it appearing to the Court that these proceedings are a breach of the Vexatious Litigant Order

**IT IS ORDERED THAT**

1. The application issued on 21 June 2021 which commenced these proceedings is struck out as an abuse of process, having been made in breach of the Vexatious Litigant Order.
2. This order is made of the court's own initiative under CPR 3.3(1). Any application for permission to apply to set aside, vary or stay the same must be made to a justice of the High Court in accordance with the terms of the Vexatious Litigant Order.
