UPON THE APPLICATION by a Claim Form dated the 28 January 2019 of Jennifer Mirembe (acting in her capacity as the Personal Representative of the Estate of Kevin Brian O'Connor Deceased and acting in her personal capacity as a beneficiary of the Estate of Kevin Brian O'Connor Deceased) the Claimant and a creditor of the above named Just & Brown Solicitors Limited (hereinafter called "the Company")

AND UPON READING the evidence



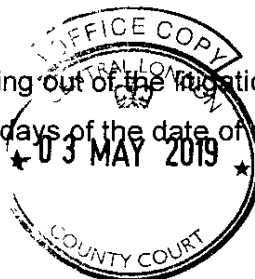
AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 20 March 2019

AND on the leave of the Court being given to amend the Claim Form to reflect the standing of the Claimant as acting in her capacity as the Personal Representative of the Estate of Kevin Brian O'Connor Deceased and acting in her personal capacity as a beneficiary of his Estate and re-service being dispensed with

AND UPON the Claimant by her solicitors undertaking to:

(A) inform the Registrar of Companies immediately on the conclusion of the litigation issued against the company under Claim Number E00MK869 seeking damages for alleged negligence, breach of duty, sale of assets at an undervalue and failing to account for monies received arising out of their acting in the Administration of the Estate of Kevin Brian O'Connor Deceased

(B) should any award from the Court arising out of the litigation referred to in undertaking (A) not be paid within 28 days of the date of any such award,



within 7 days thereafter present a petition to the Court seeking the compulsory winding up of the company

- (C) inform the Registrar of Companies of the title and Court reference number of the said Petition immediately after issue
- (D) inform the Registrar of Companies of the outcome of the hearing of the said Petition
- (E) within 21 days of the making of any compulsory winding up Order in respect of the company deliver an Office Copy of that Order to the Registrar of Companies
- (F) inform the Registrar of Companies on the conclusion of the Claimant's claim against the company by any other means

AND UPON the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Just & Brown Solicitors Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 8330595 Limited
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"




(5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00

(6) the hearing fixed for the 9 May 2019 at 2:00 pm be vacated
